ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying PPME Local 2003 (Roads) as the exclusive bargaining representative of the bargaining unit described below.



PROPOSED DECISION AND ORDER

Statement of the Cases

Public Professional & Maintenance Employees, Local 2003 (PPME) filed petitions for clarification and amendment of bargaining unit with the Public Employment Relations Board (Board) pursuant to section 13 of the Public Employment Relations Act (Act) and Board Rules 4 6 and 4 7

In Case No 7222, PPME seeks to clarify whether the job classification of Shop Operations Supervisor is currently included in a bargaining unit represented by PPME

In Case No 7224, PPME seeks to amend the PPME-represented bargaining unit to include the Shop Operations Supervisor

Keokuk County (County) resists PPME's petitions contending that the Shop Operations Supervisor is excluded from the bargaining unit as a supervisor within the meaning of section 4 2 of the Act

mechanics, and because Klett has effectively recommended the hire and discharge of mechanics

Based on the foregoing, I issue the following

ORDER

In Case No 7222, PPME's petition to clarify the current bargaining unit is dismissed

In Case No 7224, the bargaining unit previously certified by the Board in Case No 2570 is amended to read as follows

INCLUDED All of Keokuk County Secondary Road Department regular full-time employees

EXCLUDED County Engineer, First Assistant to the Engineer, Secretary, Maintenance Superintendent, Shop Operations Supervisor and all other employees of Keokuk County excluded under Section 4 of the Act


ORDER OF CERTIFICATION
