Said stipulation having been tentatively approved by the Board and posted in conformance with the Board's Rules and Regulations, no objections having been filed thereto, and the Board having no objections;




ORDER

EXCLUDED: All non-professional and the following professional personnel are excluded: superintendent, building principals, teachers aides, athletic directors, and gifted program coordinator.

IT IS HEREBY ORDERED BY THE BOARD that Mid-Prairie Education Association, should be and hereby is designated and certified by this Board to be the exclusive bargaining representative for the employees of Mid-Prairie School District, a public employer, in the following bargaining unit

INCLUDED The following professional personnel under direct contract (ie hired and paid) to the Mid-Prairie Community School District shall be included in the bargaining unit Classroom teachers, guidance counselors, librarians, special education teachers, special resource staff, department heads, athletic directors, administrative assistants, (Junior high administrative assistant, also teaches four math classes and a full-time teacher teaches six classes Works with curriculum, budget, scheduling and fills in for the principal when he is out of the building Does not have the power to hire or discharge personnel and does not evaluate teachers), media specialist, and nurse

EXCLUDED All non-professional and the following professional personnel are excluded Superintendent, building principals, and teacher aides
