ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying PPME Local 2003 (Support Staff) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-15.4 and no postelection challenges were filed pursuant to PERB subrule 15.2(4). Therefore, the Board finds that an order of recertification should be issued.



Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the Ankeny Community School District initially determined in PERB Case No. 4809, and the certification of PPME Local 2003, are amended to provide:

INCLUDED: All regular full-time and part-time bus drivers; custodians; maintenance employees; mechanics; delivery drivers; food service employees; print shop employees; associates; building secretaries; maintenance and transportation secretaries, and bus chaperones.

EXCLUDED: All professional employees; central office employees; print shop supervisor; food service managers; transportation supervisors; custodial supervisor; maintenance supervisor; and all others excluded by Iowa Code section 20.4.


