A public notice of the Board's revised proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the revised proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the City of Centerville initially determined in PERB Case No. 1412 and amended in 7070, and the certification of Public Professional and Maintenance Employees, Local 2003, IUPAT, are amended to provide:

INCLUDED: All employees of the City of Centerville in the Street, Sewer Utility, and Water Utility Departments.

EXCLUDED: Street Commissioner, Sewer Utility Supervisor, Water Utility Supervisor, seasonal employees and all other employees excluded by Iowa Code section 20.4.

ORDER OF CERTIFICATION


