ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying PPME Local 2003 (Mixed) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621–5.4, and no postelection challenges were filed pursuant to PERB subrule 621–5.2(1)(b)(2) and PERB rule 621–5.6(8). Therefore, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that PPME Local 2003 (Mixed) is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Davis County Community School District:

INCLUDED: All employees of the Davis County Community School District including teacher aides, custodians, cooks, bus drivers, mechanics, and secretaries, including Principal's secretary and Assistant Principal's secretary.

EXCLUDED: Teachers and Administrators, Supervisor of Building and Grounds, Supervisor of Food Services, Supervisor of Transportation, Board of Education secretary, Superintendent's secretary, Assistant Superintendent's secretary. Students working 20 hours per week or less, substitutes and temporary employees and all others excluded by Section 4 of the Act.
