AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.


IT IS THEREFORE ORDERED that the bargaining unit of employees of the City of Eldora, Iowa, initially described in PERB Case No. 7926 and the certification of Public Professional and Maintenance Employees Local 2003, are amended to provide:

INCLUDED: All full-time and permanent part-time employees in the following classifications Police Officer, Police Sergeant, Mechanics, Equipment Operator/Laborer, Billing Clerks, Utility Clerks, Street Department, Cemetery, Waste Water Department and Water Department.

EXCLUDED: Police Chief, Police Captain, Department Directors, City Clerk, Deputy City Clerk and all others excluded by Section 20.4 of the Act.

ORDER OF CERTIFICATION

The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by Public Professional and Maintenance Employees Local 2003, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.
