ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying PPME Local 2003 (Roads) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621–15.4 and no postelection challenges were filed pursuant to PERB subrule 15.2(4). Therefore, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that PPME Local 2003 (Roads) is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Jasper County:

INCLUDED: All employees of the Jasper County Secondary Roads Department, including Motor Grader Operators, Truck Drivers, Mechanic (1& 2), Mechanic's Helper, Crawler Excavator Operator, Sign Man 1, Skilled Laborers, Accounting Clerk/Computer Specialist, Survey Design Specialist/RLS, Civil Technician (1, 2 & 3) and Working Foreman (Bridge, Motor Patrol, Pipe & Sign).

EXCLUDED: County Engineer, Assistant Engineer, County Surveyor, Maintenance Superintendent, Assistant Maintenance Superintendent, Assistant to the Engineer, Shop Foreman, and all other employees excluded by Iowa Code section 20.4.

Said Stipulation having been tentatively approved by the Board and posted in conformance with the Board's Rules and Regulations, and no objections having been filed thereto:


ORDER

EXCLUDED: Engineer Assistant to the Engineer, Motor Grader Foreman, Bridge Foreman, Shop Foreman, Pavement Maintenance Foreman, Secretary and Design Ass't/RLS, Engineering Staff, office and clerical employees, and all others excluded by Section 4 of the Public Employment Relations Act.


