ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying PPME Local 2003 (Support) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621—5.4, and no postelection challenges were filed pursuant to PERB subrule 621—5.2(1)(b)(2) and PERB rule 621—5.6(8). Therefore, the Board finds that an order of recertification should be issued.



EXCLUDED: All teachers, teachers' aides, blue collar employees, all others excluded by Section 4 of the Act, who are employed by the Ottumwa School District and the following offices of the Ottumwa Board of Education: Secretary to the Superintendent, Secretary to the Personnel Director, Bookkeepers and Insurance Clerk, Secretary to the Business Manager and Accounts Payable Clerk, Secretary to the Curriculum Directors, Payroll Clerk, Census Clerk and Attendance Office and Secretary to the High School Principal.


Said stipulation having been tentatively approved by the Board and the Board having no objections,
