ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying SEIU Local 199 (Physical Plant) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621—5.4, and no postelection challenges were filed pursuant to PERB subrule 621—5.2(1)(b)(2) and PERB rule 621—5.6(8). Therefore, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that SEIU Local 199 (Physical Plant) is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Iowa City Community School District:

INCLUDED: All non-supervisory blue collar physical plant employees which include the following job classifications: custodians, food service drivers, maintenance workers, electricians, plumbers, heating ventilation and air-conditioning, custodial substitutes, mechanics, cabinet makers, refuse haulers, campus mail delivery persons, painters and warehousemen.

EXCLUDED: Supervisors and Physical Plant Directors, and all those excluded by Section 4 of the Act.



ORDER OF CERTIFICATION



EXCLUDED: All supervisors and heads of department of the Iowa City Community Schools, Directors of Physical Plant, Supervisor of Custodians, and Supervisor of Carpenters, Electricians, Plumbers, Boilers and Grounds, and all those excluded by Section 4 of the Act.
