ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying IUOE Local 234 as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.


IT IS THEREFORE ORDERED that IUOE Local 234 is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Sioux City Community School District:

INCLUDED: All custodial, engineer, storeroom, and maintenance employees.

EXCLUDED: Director of physical operations, general foreman, construction foreman, transportation foreman, utilities foreman, custodial foreman, teachers, administrative personnel, secretaries and aides, food service workers, bus drivers, and all others excluded by Section 4 of the Act.

ORDER OF CERTIFICATION


NOW on this 11th day of March 1976, the Board being advised,
