ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Solon Education Association as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, and no postelection challenges were filed pursuant to PERB subrule 621-5.2(1)(b)(2) and PERB rule 621-5.6(8). Therefore, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Solon Education Association is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Solon Community School District:

INCLUDED: All Professional employees of the Solon Community School District, including classroom teachers, guidance counselor, librarian, nurses, Title I teachers, part-time teachers, department heads, special education teachers, and special resource staff.

EXCLUDED: Superintendent, principals, assistant principals, athletic director, and all other personnel excluded by Section 4 of the Act.

should be and hereby is designated and certified by this Board to be the exclusive bargaining representative for the employees of


