ORDER OF RECERTIFICATION

Following the filing of an order directing an election, a retention and recertification election pursuant to Iowa Code section 20.15(2) was conducted under the supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Chauffeurs, Teamsters and Helpers, Local Union No. 238 as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule 621-5.4, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Chauffeurs, Teamsters and Helpers, Local Union No. 238 is hereby recertified as the exclusive bargaining

PROPOSED DECISION AND ORDER

Statement of the Case

This case concerns an amendment of bargaining unit petition filed by Chauffeurs, Teamsters and Helpers, Local Union No. 238 (Union). The Union seeks to amend an existing bargaining unit represented by the Union to include the job classification of transit operations manager. Southeast Iowa Regional Planning Commission (Commission) contends that the transit operations manager should be excluded from the bargaining unit by section 4.2 of the Public Employment Relations Act (Act).

A public hearing was held on June 24, 2009, at which the Commission and Union were provided a full opportunity to present written evidence and testimony. Post-hearing briefs were received on July 20, 2009.

is a manager under the Act would require a broad and not a narrow view of Huebner's actual job duties and responsibilities, which establish that Huebner provides a supportive role to other Commission personnel who have the authority to make, implement, and change Commission policy. Therefore, Gerald Huebner is not a representative of a public employer within the meaning of section 4.2 of the Act.

Based on the foregoing, the following is issued:


ORDER


