AMENDMENT OF CERTIFICATION

Four petitions for amendment of certification were filed with the Public Employment Relations Board by Teamsters Local Union No. 421, seeking to amend its certifications as representative of four bargaining units of employees of the City of Dubuque. The petitions propose that the certifications be amended to reflect Local 421's merger into Teamsters Local Union No. 120.

A public notice of PERB's proposed decision to grant the requested amendments was issued and posted in accordance with PERB's rules. No objections to the proposed decision have been filed within the time specified in that notice.

IT IS THEREFORE ORDERED that the certification of the Teamsters Local Union No. 421 as the exclusive bargaining representative for certain employees of the City of Dubuque issued in PERB Case No. 7039 is hereby amended so that the certified representative will hereafter be identified as TEAMSTERS LOCAL UNION NO. 120.

ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by Teamsters Local Union No. 421, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that Teamsters Local Union No. 421 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of the City of Dubuque:

INCLUDED: Bus Operators (full-time and part-time).

EXCLUDED: All other public employees as set forth in Section 4 of the Public Employment Relations Act and employees of the Transit Department classified as Transit Manager, Transit Garage Supervisor, Lead Mechanic, Mechanic, Transportation Cashier, Transportation Clerk, Service Worker, Loans and Grants Clerk and Clerk Typist.
