ORDER OF RECERTIFICATION

Following the filing of an order directing an election, the Public Employment Relations Board (Board) conducted a retention and recertification election pursuant to Iowa Code section 20.15(2). The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the employees in the bargaining unit voted in favor of retaining and recertifying Teamsters Local 120 (Food Service) as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election were filed as provided for in Iowa Code section 20.15(4) and PERB rule 621–5.4, and no postelection challenges were filed pursuant to PERB subrule 621–5.2(1)(b)(2) and PERB rule 621–5.6(8). Therefore, the Board finds that an order of recertification should be issued.

IT IS THEREFORE ORDERED that Teamsters Local 120 (Food Service) is hereby recertified as the exclusive bargaining representative of the following bargaining unit of employees of Dubuque Community School District:

INCLUDED: All regular full-time and part-time Food Service (Cafeteria) employees assigned to work in the classifications of; Cook Manager, Assistant Cook Manager, Head Cashier, Assistant Cashier, Food Service Worker.

EXCLUDED: Food Service Supervisor, Secretary to the Board Secretary, Food Service Bookkeeper and all other persons excluded by Section 4 of the Act.

AMENDMENT OF CERTIFICATION

A public notice of PERB's proposed decision to grant the requested amendments was issued and posted in accordance with PERB's rules. No objections to the proposed decision have been filed within the time specified in that notice.

IT IS THEREFORE ORDERED that the certification of the International Brotherhood of Teamsters, Chauffeurs, Warehousemen & Helpers of America, Local No. 421 as the exclusive bargaining representative for certain employees of the Dubuque Community School District issued in PERB Case No. 2248 is hereby amended

so that the certified representative will hereafter be identified as TEAMSTERS LOCAL UNION NO. 120.
