

AMENDMENT OF CERTIFICATION



ORDER OF CERTIFICATION

NOW on this 8th day of June 1977, the Board being advised that an election was conducted pursuant to Order of the Board, and that Over the Road and City Transfer Drivers, Local Union No. 147 an employee organization, received an affirmative vote of the majority of employees in the bargaining unit, and the Board having further found that the employee organization has fully complied with all regulations of the Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Over the Road and City Transfer Drivers, Local Union No. 147 should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of Audubon County Board of Supervisors a public employer, in the following bargaining unit:

INCLUDED: All employees in the auditor's office, sheriff's office, treasurer's office and the sanitary land fill including sheriff's deputies, radio dispatchers, clerks, clerk/dispatchers, sanitary workers, janitor, and clerks in the Treasurer's office.

EXCLUDED: All elected officials and all others excluded by Section 4 of the Act.
