AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed under Section 13 of the Public Employment Relations Act [Act], Chapter 20, Iowa Code (1991), and Rule 4 6 of the Public Employment Relations Board [Board or PERB], the parties filed with the Board a Stipulation of Bargaining Unit

Said Stipulation has been tentatively approved by the Board; a Public Notice of Proposed Decision of Amendment of Bargaining Unit has been posted in conformance with PERB Rules; an objection was filed and was subsequently withdrawn, therefore:

IT IS HEREBY ORDERED that the bargaining unit previously determined in Case No 3523, and the certification of Teamsters Local No. 238, is amended to read as follows:

INCLUDED: All regular full-time and regular part-time police officers, including the Chief of Police.

EXCLUDED: All elected officials and other City employees.


