IT IS THEREFORE ORDERED that Over the Road, City Transfer Drivers, Dockmen, Helpers, Warehousemen, Inside Workers, State, County and Municipal Employees, Teamsters 147, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for employees of the City of Carroll, a public employer, in the following bargaining unit



EXCLUDED: All supervisory employees (including, but not limited to the following positions Street Superintendent, Water Superintendent, Wastewater Superintendent, Golf Course Superintendent, Parks Superintendent, Rec Center Director, and Maintenance Specialist), All professional employees (including, but not limited to the following positions City Manager, Director of Public Works, Park and Recreation Director, City Clerk/Finance Director, Building Official, Engineering Technician and Librarian), All confidential employees (including, but not limited to the following positions Deputy City Clerk, Secretary (Administration), and Data Processing Clerk(s)), All part-time employees, All temporary, fill-in, substitute and seasonal personnel, All independent contractors and subcontractors, All guards and security personnel, All employees of the Public Safety Department (Police, Parking Enforcement and Fire), All employees of the City-County Communications Commission, and All other positions excluded by the PERA
