ORDER OF CERTIFICATION


NOW, on this 27th day of November, 1979, the Board being advised that an election was conducted pursuant to Order of the Board, and that a majority of the ballots were cast for Over the Road and City Transfer Drivers, an employee organization; Local 147, and the Board being further advised that said employee organization has complied with all requirements of the Act and the rules and regulations thereunder;

IT IS HEREBY ORDERED that Over the Road and City Transfer Drivers, Local 147, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of Creston, a public employer, in the following bargaining unit:

INCLUDED: All maintenance employees, meter readers, water plant employees and office clerical employees of the City of Creston, Iowa Waterworks.

EXCLUDED: Waterworks superintendent, maintenance superintendent, water plant superintendent, plant supervisor, office supervisor and bookkeeper and others excluded by the Act.
