AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation in which they agreed to an amendment of the bargaining unit and the certification of Chauffeurs, Teamsters and Helpers, Local Union No. 238. The parties' stipulation was tentatively approved by the Board, a public notice of the Board's proposed decision to amend the bargaining unit and Local 238's certification in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the Ottumwa Transit Authority initially determined in PERB Case No. 7159, now employed by the City of Ottumwa as successor to the Ottumwa Transit Authority, is amended to provide:

INCLUDED: All transit bus drivers, bus cleaners and dispatchers.


EXCLUDED: All clerical employees, supervisors and other employees excluded by Iowa Code section 20.4.

IT IS FURTHER ORDERED that the certification of Chauffeurs, Teamsters and Helpers, Local Union No. 238, as the exclusive bargaining representative for this bargaining unit is amended to reflect the unit's employment by the City of Ottumwa, successor to the Ottumwa Transit Authority.

ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by Chauffeurs, Teamsters and Helpers, Local Union No. 238, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that Chauffeurs, Teamsters and Helpers, Local Union No. 238 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of the Ottumwa Transit Authority:

INCLUDED: All bus drivers and all bus cleaners of the Ottumwa Transit Authority.

EXCLUDED: Transit Administrator, Administrative Assistants, Bus Maintenance Technician and all others excluded by Section 4 of the Act.
