


IT IS THEREFORE ORDERED that the bargaining unit previously determined in Case Nos. 227 and 339, and amended in Case Nos. 1069 and 2798, and the certification of Teamsters Local 147, is amended to read as follows:

INCLUDED: All regular full-time patrolpersons, patrolpersons-jail, detectives, dispatchers and regular part-time patrol assistants employed by the Polk County Sheriff's Office.

EXCLUDED: All division chiefs, assistant division chiefs, lieutenants, sergeants, chief administrative second deputy, communications center supervisor, administrative supervisor, jail cook, identification technician, account clerks, secretaries, weapon permit technician, legal stenographer, word processing specialist, records clerk, jail services aide, program specialist, administrative analyst I, cooks, stop processor, booking clerks, public service clerks, and all other county positions represented by any other certified bargaining representative or excluded from coverage by the Act.


ORDER
