AMENDMENT OF CERTIFICATION

The Public Employment Relations Board filed an agency-initiated petition seeking to amend the certification of Chauffeurs, Teamsters and Helpers, Local 238 to correct the error in the public employer's name to "Webster County Metropolitan Law Enforcement Telecommunications Board."

The Chauffeurs, Teamsters and Helpers, Local 238 is the certified representative of the bargaining unit of dispatchers. The bargaining unit was originally described in PERB Case No. 6689. The employee organization's name was amended in Case No. 6982.

The current description of the unit, as contained in Case No. 6689, provides:

INCLUDED: All full-time and regular part-time dispatchers.

EXCLUDED: Supervisors, confidential employees and others excluded by the Act.

The composition of the bargaining unit remains unchanged.

A public notice of PERB's proposed decision to grant the requested amendment was issued and posted in accordance with PERB subrule 621-4.8(4).


No objections to the proposed decision were filed within the specified time.

IT IS THEREFORE ORDERED, that the certification of Chauffeurs, Teamsters and Helpers, Local 238 as the exclusive bargaining representative for dispatchers is hereby amended to reflect the correct name of the public employer which is “Webster County Metropolitan Law Enforcement Telecommunications Board.”

AMENDMENT OF CERTIFICATION



ORDER OF CERTIFICATION


