Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules. No objections to the proposed decision were filed.


IT IS THEREFORE ORDERED that the bargaining unit of Windsor Heights employees, initially determined in PERB Case No. 7240, is amended to provide:

INCLUDED: All regular full time police officers of the City of Windsor Heights Police Department.

EXCLUDED: Chief of Police, Police Captain, Police Lieutenants, Sergeants, Chief Dispatcher and all others excluded by Iowa Code section 20.4.

ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20.14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by Chauffeurs, Teamsters and Helpers, Local Union No. 238, that no objections to the election were filed as provided for in Iowa Code section 20.15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20.25.

IT IS THEREFORE ORDERED that Chauffeurs, Teamsters and Helpers, Local Union No. 238 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of the City of Windsor Heights:

INCLUDED: All regular full time employees of the City of Windsor Heights Police Department, including Sergeants, Patrolmen.

EXCLUDED: Chief of Police, Chief Dispatcher, Dispatcher, Detective Sergeant and all other persons excluded by Section 4 of the Act.
