AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621—4.6(2), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the County of Winneshiek initially determined in PERB Case No. 6369, are amended to provide:

INCLUDED: All regular full time and all regular part time Jailers and the Assistant Jail Administrator employed by the Winneshiek County Sheriff's Office.

EXCLUDED: All elected officials, supervisors, including Jail Administrator, confidential employees and all other persons excluded by the Act.
