
**IT IS THEREFORE ORDERED** that the bargaining unit previously determined in Case No 4171, and the certification of Turkey Valley Education Association, is amended to read as follows

**INCLUDED:** All professional employees, classroom teachers, (basic curriculum, fine arts, remedial, special education and vocational), guidance counselors, media personnel (librarians and audio-visual directors), specific learning disability and other teaching specialists, school nurse, and employees teaching exclusively in private schools

**EXCLUDED:** Superintendent, principals, administrative assistants, temporary employees, cooks, janitors, bus drivers, maintenance personnel, teacher aides, teacher associates, secretaries and all others excluded by Section 4 of the act


Said Stipulation having been tentatively approved by the Board and posted in conformance with the Board's Rules and no objections having been filed thereto:

EXCLUDED: Superintendent, principals, administrative assistants, temporary employees, cooks, janitors, bus drivers, maintenance personnel, teacher aides, teacher associates, secretaries and school nurse, and all others excluded by Section 4 of the act.

AMENDMENT OF CERTIFICATION

Upon a petition for amendment of certification duly filed under §13 of the Public Employment Relations Act and Rule 4.6 of the Public Employment Relations Board's Rules and Regulations, the parties waived hearing and filed with the Public Employment Relations Board stipulation of bargaining unit including the job classifications of part-time professional employees into the previously determined bargaining unit.

Said stipulation having been tentatively approved by the Board and the Board having no objections,

ORDER

IT IS HEREBY ORDERED that the bargaining unit previously determined in case number 214 and the certification of Turkey Valley Education Association in that case be and hereby is amended to read as follows

INCLUDED All professional employees, classroom teachers (basic curriculum, fine arts, remedial, special education and vocational), guidance counselors, media personnel (librarians and audio-visual directors), specific learning disability and other teaching specialists.\*

EXCLUDED Superintendent, principals, administrative assistants, temporary employees, employees teaching exclusively in private schools, cooks, janitors, bus drivers, maintenance personnel, teacher aides, teachers associates, secretaries and school nurse and all others excluded by Section 4 of the Act.

\*Part-time professional employees teaching at the Turkey Valley Community School shall now be included as members of the bargaining unit.

EXCLUDED Superintendent, principals, administrative assistants, temporary employees, cooks, janitors, bus drivers, maintenance personnel, teachers aides, teachers associates, secretaries and school nurses and all others excluded by Section 4 of the Act
