AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20 15 and PERB rule 621-4 6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed within the time specified in the notice.

IT IS THEREFORE ordered that the bargaining unit of employees of Monroe County initially determined in PERB Case No 2923 and amended in Case Nos 3587 and 5282, and the certification of United Automobile, Aerospace and Agricultural Workers of America (UAW), Local #74, is amended to read as follows:

INCLUDED All regular full time and part time employees in the classifications of sheriff deputies, dispatchers, jailers and office clerks.

EXCLUDED All other employees of Monroe County including Chief Deputy, supervisory employees, confidential employees and all others excluded by Section 4 of the Act.





Said Stipulation having been tentatively approved by the Board and posted in conformance with the Board's Rules and Regulation, and no objections having been filed thereto:


